EXECUTIVE DIRECTOR'S REPORT

Dear Friends,

I wanted to share some highlights from this year's 17th Korea-America Student Conference (KASC)—it was an unforgettable experience for the five leaders and 20 students who participated.

This year's theme, "Embracing Complexity: Navigating Intersections in Global Diplomacy for a Shared Tomorrow," tackled the complex connections in today's global relationships. To dive into this theme, the student leadership team brought in amazing guest speakers from different fields. They also partnered with the Japan-America Student Conference (JASC) on a joint program. This collaboration made KASC 17 even more special, giving us a rare chance to exchange ideas and perspectives between Korean, American, and Japanese students.

Five students made up the KASC's Executive Committee (EC)—three from South Korea and two from the U.S. This leadership team organized the academic and cultural sessions and handled the complicated logistics of moving the conference across two countries during the three-week program. Sessions with experts and delegates led to engaging discussions on U.S.-ROK relations for the 20 delegates, giving them the chance to explore everything from international relations to business, government partnerships, security alliances, and cultural exchanges.

The Roundtable (RT) groups are always a core part of the conference where each delegate joins a team focused on a specific topic. KASC 18 tackled the topics: (1) Business, Law, and Diplomacy in a Global World, (2) Arts and Media, (3) Environment and Technology, (4) International Relations and Politics, (5) Trade and Economic Cooperation.

Each RT group researched its topic and presented initial ideas at the DC Internal Site Forum. Then they refined their research for the Final Forum, where they presented the projects at the American Diplomacy House with support from the U.S. Embassy in Seoul. They covered key topics like the “Spirit of Camp David” (a joint U.S.-ROK-Japan statement), the impact of global sanctions, how art fosters cultural diplomacy, the CHIPS and Science Act, and green energy collaboration.

The ECs worked hard to arrange top speakers through organizations like the Korea Society and Seoul National University. Other memorable programs included a briefing and networking reception at The Asia Group and a visit to the American Chamber of Commerce in Seoul. Delegates enjoyed the Six-Party Talk simulation at the Korea Economic Institute and a tour of the United Nations.

Wrapping up with the Final Forum at the American Diplomacy House in Seoul was the perfect way to close out the conference and lead into the KASC 17 x JASC 76 collaboration, inspired by meetings at the 2024 U.S.-Japan-Korea Forum.

The three intense weeks of discussions, hands-on projects, and cultural learning, helped them better understand each other's cultures. It was an opportunity to strengthen the bond between the U.S. and South Korea, while also building student skills in communication and leadership. I'm proud of what these incredible student leaders accomplished and I hope you enjoy reading more about this year's program in this journal.

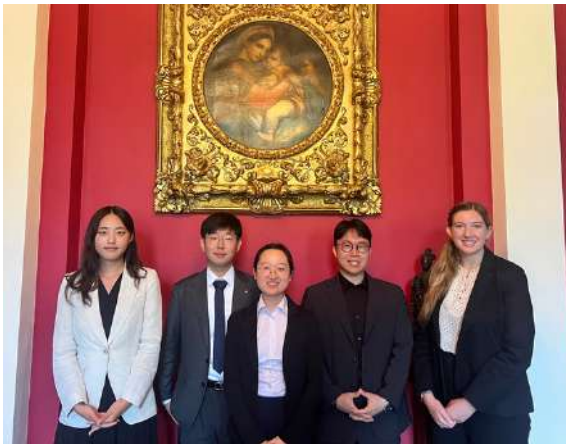


In the Environment and Technology roundtable, participants will discuss the intersections of environmental issues and technological advancements in our rapidly developing world. These two areas are inherently tied together, wherein the development and usage of technologies affects how much and in what way we impact the environment. Some technologies may cause a significant negative impact on the environment, while others can influence a positive one. Relations between the US and ROK have long collaborated on lots of issues surrounding tech and the natural world – whether that be explicitly or inadvertently – and continue to do so even more today.

For the KASC 17 Environment and Technology roundtable, this group focused on green energy initiatives and proposals for supporting developing countries. They examined how green energy solutions can be scaled to help these nations achieve sustainable development while addressing the challenges of climate change.

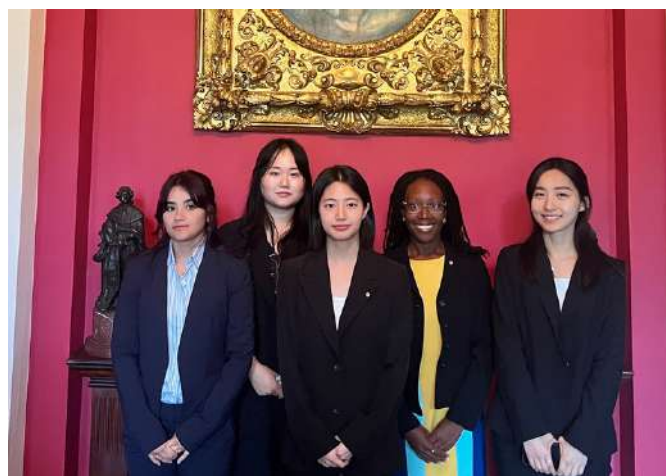

The United States and Republic of Korea have forged a strong partnership for 70 years and now become a great economic alliance. Bilateral trade is a central component of South Korea-U.S. economic cooperation.

One of the milestones is the Korea-U.S. Free Trade Agreement (KORUS FTA). FTA reduces tariffs across various industries and emphasizes intellectual property rights protection and labor. On the other hand, protectionism is a trend around the world. There is a need to explore ways to promote mutual benefits and strengthen economic cooperation.

For the KASC 17 Trade and Economic Cooperation roundtable, this group focused on the CHIPS and Science Act, exploring its impact on both the United States and South Korea. They analyzed how the Act's provisions for semiconductor production and technological innovation affect bilateral economic ties, highlighting both opportunities and challenges for collaboration in the global tech industry.

Beginning with government and politics, within the context of the current topic, we'll delve into some of the key aspects.

In the realm of government and politics, one vital aspect is the formation of alliances and partnerships. Countries establish diplomatic ties to enhance their international standing and to collaborate on issues of common interest.

For the KASC 17 International Relations and Political Science roundtable, this group focused on the Camp David Declaration between the U.S., South Korea, and Japan, offering a detailed presentation that examined its implications for regional security and diplomacy. The group also highlighted the collaborative efforts between KASC and JASC, demonstrating how their joint analysis enriched the discussion and provided a comprehensive perspective on the evolving trilateral relationship.

KASC met Jesse Finkel and Alexine Carr at the U.S. Department of State. Their diverse diplomatic experiences provided valuable insights, and they discussed key issues in U.S.-Korea relations, including diplomatic priorities and regional security concerns.

We had the opportunity to meet Julie Turner, the Special Envoy on North Korean Human Rights Issues at the Bureau of East Asian and Pacific Affairs. She shared valuable insights into the human rights challenges in North Korea and the U.S. efforts to address these issues through diplomacy.



THE KOREA ECONOMIC INSTITUTE

At the Korea Economic Institute, we took part in a 6-party simulation, representing different countries. It provided valuable insight into the complexities of international diplomacy and negotiations.



DC HIGHLIGHTS

CAPITOL HILL

Toured Capitol Hill, gaining insight into the U.S. legislative process. The visit offered a close look at the Capitol building, congressional offices, and the chambers where laws are made, deepening our understanding of Congress's role in shaping national policy.



THE KOREA FOUNDATION

KASC 17 met former Minister of Trade, Yeohan-koo, who briefed us on South Korea's trade policies and strategies. His insights provided a valuable understanding of the country's approach to global trade and economic diplomacy.

Through the D.C. forum, each of delegate had the opportunity to give a presentation on our RT topics. It was a valuable experience to share our findings and insights, while also engaging with others' perspectives and discussions on key issues.

At The Korea Society, we experienced cultural arts like pansori, which blend Korean and American traditions. It was a great opportunity to share Korea's unique heritage with the American delegates and promote cross-cultural understanding.

Visited The MET's Linkages Exhibit, where Eleanor Hyun, Associate Curator of Korean Art at the Korea Foundation and Samsung Foundation of Culture, curated our tour. Thanks to her, we gained valuable insights into the exhibit and explored the deeper cultural connections between Korea and the world.



BLOOMBERG HQ

Went to Bloomberg's HQ, gaining insight into how the company uses data, technology, and journalism to shape global markets. Was a fascinating chance to see their state-of-the-art operations and how they deliver real-time financial news and analysis.
